## **BOARD OF COMMISSIONERS** **ANNUAL DISTRICT ELECTION MEETING**


Monday, October 4, 2021



There being no other nominations, a motion was made, seconded, and unanimously approved that the Secretary cast one ballot for Commissioner Colligan to be elected Treasurer.
